Dr. Boone has extensive work experience. She is the owner of Dr. Patricia M. Boone LLC, which offers a variety of services based on her Doctorate Degree in Counseling and her experience as a Hospital Chaplain and Counselor. She is a Professional Business Consultant. She is a Certified Mediator in General Business and Real Estate. She is a Speaker, Announcer, Songwriter and Artist. As an Ordained Minister, she officiates at Weddings and Funerals in the Colorado Springs area. She also officiates at Pet Funerals, officiating at no charge at funerals for Military Dogs, Police Dogs, Assistance and Seeing Eye Dogs and ceremonies for Animal Rescue Organizations. She officiates at Equine Funerals of Tribute for Championship Horses. She provides Personal Development Consulting & Advisory Services for Marriage, Pre-marital and Re-marital; Divorce Property Settlement; and Holistic Health, the subjects of her three books in *The Life Series* that are featured on Amazon.com. Her new book is "How To Get What You Want in Any Language," a new, fast and quick language system for travelers, business people and military personnel. Prior to moving to Colorado Springs in 1999, she owned a Mail Boxes Etc. for 10 years that was in the top 200 of 2000 stores worldwide in sales. Prior to that, while working on her graduate degrees, she was head of the International Department for a Travel Agency in Atlanta. She owned Stone Mountain Bicycle Rental at Stone Mountain State Park in Atlanta, becoming the first female concessionaire in the state of Georgia. She was a CPE (Clinical Pastoral Education) Instructor at Southern Regional Medical Center in Atlanta, a Certification she earned from Emory University. She sold Real Estate in Atlanta, both Commercial and Residential, was head of the Farm and Land Department, and earned a GRI (Graduate, Realtors Institute) designation from the University of Georgia. She has been an Accountant, a Teacher (Math, Science and Reading) and a reading demonstration Teacher for the state of Texas, as well as a model at the Dallas Merchandise Mart. Immediately upon graduation from college, she was

hired by Lockheed Aerospace as a Fortran IV Programmer and then by Boeing Aerospace as a Technical Writer and Editor for the Saturn V Space Program.

As part of her extensive airline experience, she completed Pilot Ground School while she was in college. She was a Flight Attendant and then promoted to Flight Attendant Supervisor for Eastern Metro Express. She has been a Reservations Agent. She has been a Gate Agent. She handled the Accounting, Customs, and Weight & Balance for United Airlines in Wilmington, North Carolina, a port city. She worked at the Ticket Counter. She was trained to load and unload bags on a Boeing 727. As Customer Service Agent for United Airlines in Wilmington, North Carolina, she was nominated for Best Customer Service Agent in the United States and actually won Best Customer Service Agent in the Southeast United States. She knows how everything works together at an airport, and the importance of working together. She worked at Hanger One, the only general aviation at Atlanta International, as well as Hartsfield-Jackson Atlanta International Airport, one of the busiest airports in the world, whose mission statement is “to be the world's best airport by exceeding customer expectations.” She believes that if COS thinks like an international airport, they can become the best international airport in the world.
